PASTOR'S REPORT

Every Sunday in 2022 was an opportunity to gather as the Body of Christ and give thanksgiving to our Triune God. While the pandemic and other obstacles continued to haunt us, a group of very faithful people came together to worship, joined by some participating through livestreaming. Often the sanctuary felt bare, and discouragement would come and go. But for all who continued to do the ministry of our Lord-week in and week out-from worship to education, fellowship, feeding, maintaining, repairing, cleaning, caring, calling and so much more, blessed are you. I am especially grateful for Eastminster's encouragement of children and youth in assisting in worship leadership, and in some cases, taking the lead in worship.

As Eastminster continues to feed the bodies of many, our souls are fed by the bread and cup of Holy Communion. We remember the Lord as we eat and drink, we celebrate the presence of his Spirit with us in these moments, and we look forward to the coming again of Jesus. At the invitation of our Lord, we continued to "eat and drink" every month. Although several other outreach ministries took on a different look this year; they are nonetheless, the work of the Lord in all their forms. The Pleasant Grove Food Pantry has been a true God-send during the harsh realities that came with 2022 and those who gave of their time to serve are truly God's messengers of hope. The Wilkinson Center, Presbyterian Children's Homes and Service and other benevolences supported by Eastminster are our reminder that it truly takes a village—or faith communities—to bring hope to a hurting people.

For the worshipful services and celebrations of Laura Bennett and Chris Calkins and for Sean Turner and Molly Fockler, we rejoice, and we continue to live out our promise to support them in their lives together.

Two of those hearts joined together years ago, Matt and Brittney Bennett, brought joy to the congregation as we baptized their little angel, and God's child, Piper Rose Bennett. As so many at Eastminster have known for a long time the joy of grandchildren and great grandchildren, all first-time grands have learned this past year with full hearts.

Eastminster was blessed to welcome two new members-who are anything but new-through Confirmation. Sophia Veloz and AbbyGayle Flores, children of the church, amazed and awed us as they spoke of their faith, and their desire to grow spiritually even deeper. To you Eastminster, I say thank you for taking a leap of faith and calling Audrey Webb to serve as a Resident through the Center for Youth Ministry Training and Austin Presbyterian Theological Seminary programs. Her dedication to providing opportunities for youth to grow in grace and wisdom was and is a bright spot in the ministry of Eastminster. Although Audrey is no longer with Eastminster, she has done what she was called to do...she laid a foundation that has, particularly Sophia and AbbyGayle, wanting to dive deeper into scripture, worship, faith and action.

Fast forward, and it became very clear late fall that in order to follow through on all God had laid on my heart meant changing directions, and this case, changing ministries. While I have no room to explain all the differences between being an installed pastor and an interim pastor, I can say the right decision to God was "yes!" My constant prayer at this point is that my "yes" will help Eastminster listen evermore closely for her "yes" from God whose plan is always good.

As I keep you all in my prayers, I hope that you will from time to time, remember me, Gary, Ryan, Katy, Jordan, Katie, Brandi, Lorrie, Molly, Morgan, Elaina...and the new little one to enter the world of Jordan and Katie in June. For being family to us all, our hearts!

HOUSE & PROPERTY COMMITTEE

Praise the Lord. 2022 was a much dryer year than 2021. We had a mild winter but a very hot and dry summer. During the year we accomplished many tasks and most of them are listed below by month. We had several volunteers that helped along the way this year and we are thankful for their prayers and support in the work that was performed to maintain the "House of the Lord".

January

- Replaced the kitchen water heater for \$1,206.20
- Replaced the office water heater for \$1,036.20
- Repaired a leak in the supply line for the irrigation system
- Put root killer in the sanctuary drain line to avoid sewer backup. (This is an ongoing maintenance process)
- Replaced air filters to the HVAC units

February

- Installed two shelves in the choir room closets
- Our internet and WIFI issues were evaluated by a consultant and a proposal was received
- The security system was repaired by DFW Security. Replaced Nursery panic switch.
- Cleaned out courtyard gutters. Found three underground drainage lines were plugged.
- Received and estimate from Heldreth Electric to replace 148 tube lights and 70 fixtures with LED lights and systems. The estimate is \$4,568.88. The work was not done due to the cost.
- Repaired playground entrance. Damaged wood and door were replaced and all areas were sealed and painted by Cousins Remodeling. Invoice was \$2,245.89.
- Annual Fire Extinguisher inspection was completed

March

- HVAC Unit #5 was replaced for \$6,800 by C&G. The system is manufactured by Goodman and carries a 10-year system on the equipment. This system services the choir room and hall area.
- Re-glued cloister door handle.
- Root killer was placed in the sanctuary bathroom drain. Ongoing maintenance.
- Security System issues were repaired by DFW Security. Replaced Fellowship Hall panic switch and repaired the main panel. Added a booster unit for the panic switches
- Put door stop in Fred's old classroom
- Replaced air filters
- Replaced water sensor in the Nursery restroom

April

- April 8th Work Day Volunteers Denise Bennett, Tony Bennett, Michele Pappas, Jim Lee, Bruce Turner and Blair Garrett
- Cleaned out plant beds and put down mulch and planted spring flowers
- Caulked and painted around the pulpit exit door
- Painted sconce lights near the pulpit exit door
- Cleaned out Maintenance room
- Replaced screws in Fellowship Hall restroom door
- Replaced missing Allen screw in kitchen sink faucet
- Replaced gate to playground

May

- Met with St. Peter's Anglican Church regarding leasing space for worship and provided a contract to them. They rented the chapel and the adjoining classroom for \$100 per Sunday. The contract expires December 31, 2022.
- Doug Carpenter installed Wireless Access Point units in the Fellowship Hall, Sanctuary and the area outside of the conference room to boost the WIFI signal to all areas of the church. Total cost was \$814.85 and was paid by a donation from the Jerri Turner Estate
- Plumber cleanout to sanctuary restroom was treated with root killer

- The 5 Sanctuary HVAC units were serviced. Units were low on freon and coils were cleaned. The invoice for the service call was \$2,175. 13 lbs. of Freon 22 were needed. The cost was donated by Advanced Texas A/C.
- C&C plumbing cleaned out the plumber clean out to the large restrooms in the main hallway and installed a cap for the line.
- Adjusted float valve in Nursery restroom commode

June

- Lawn Mogul fixed a leak in the irrigation system and replaced a valve
- Advanced Texas A/C replaced the Nursery HVAC system. The condensing compressor had burned up and the coil had several leaks. The complete system was replaced for \$8,500. Invoice paid by donation
- Due to extreme heat and humidity and a failed Nursery HVAC system the engineered hardwood floors buckled in the Nursery.
- Plumber cleanout to sanctuary restroom was treated with root killer
- Cleaned all gutters serving the courtyard area

July

- Bruce Turner removed engineered hardwood floors in Nursery
- Blair Garrett and Jim Lee cleaned the hardwood flooring and put two coats of Redgard on the Nursery floor.
- Bruce, Jim, Blair and Katie Karlen installed the existing flooring along with new engineered hardwood flooring in the Nursery total cost \$1,248.00
- Replaced condensing coil to church office HVAC system \$2,000
- Repaired the organ in the chapel \$521.00 Funds were donated for the repair
- Water remediation of the Choir Room, parlor, two classrooms and conference room. Total cost of remediation \$1,728. Damage caused by an 8-inch rain and the underground drainage system could not keep up.

August

- Water remediation invoice that was still pending from Servpro was forgiven by Carl Perazzola owner of the Servpro franchise out of North Carolina on August 12th. The amount of \$124,428.08 was not covered by the insurance claim covered by Travelers Insurance. Servpro and Travelers had been in negotiations since July 2021.
- Installed hooks in the Narthex closet for the acolyte candle lighters
- Replaced HVAC air filters
- Plumber cleanout to sanctuary restroom was treated with root killer
- Replaced all drainage pipes in the courtyard area. All work and materials were donated by Land Art of Rockwall

October

• Painted the water-stained kitchen ceiling

- Painted waiter-stained spots in fellowship hall ceiling
- Repaired the Ark in the playground

- Stained the benches in the courtyard
- Stained the Ark
- Replaced all air HVAC filters
- Replaced HVAC Unit 12B condensing compressor for the Fellowship Hall invoice was \$3,750. The work was performed by Advanced Texas A/C.

November

- Repaired heating units 12-A and 12-B replaced one capacitor and lose wire on circuit board. Repaired vent stack to the Toddler Room unit heating system. Service call and work was donated by Advanced Texas A/C.
- Plumber cleanout to sanctuary restroom was treated with root killer
- Double ovens were repaired by Rockwall County Appliance for \$943.00. Two control boards were replaced.
- Ice maker was repaired and cleaned for \$242.50 by Texas Ice Machine Co.

December

- Plumber cleanout to sanctuary restroom was treated with root killer
- Presented St. Peter's Anglican Church with a new contract effective January 1, 2023. Waiting on Grace Presbytery to approve the contract. The rental fee is \$110.00 per Sunday for use of the chapel and the adjoining classroom.
- Received broker opinions for the Eastminster Church property from Foundry Commercial and Church Realty.
- DFW Security repaired the choir classroom panic switch error message. They will replace the main panel in the month of January 2023

We had many repairs this year to our HVAC systems. We have 19 HVAC Systems and the average age of each unit is 25 years old. We have been dedicated to fix that which breaks. As you remain faithful to the church in 2023, we are blessed in the abundance of gifts that our faithful venders and friends have given to Eastminster in the form of free service and repairs over the past year.

- With thanksgiving for the lives of Bobbe Brown, Naomi Davis, Doris Little, and Charlene Pietsch, memorials of \$1,537.46 were given during 2022.

The Stewardship committee meetings were: February 13, March 13, April 3, May 1, June 30, August 14, September 11 and October 9, the meetings were held via Zoom. The Congregational Luncheon was in person on November 6.

A Committee was formed to review the 2021 Financials, consisting of Cindy Garrett, Blair Garrett, Tony Bennett, Darlene West, Dick Knox, Bruce Turner. The financial review was completed on Saturday, April 2, 2022. Cindy Garrett, 2021 Treasurer, and Tony Bennett, 2021 Assistant Financial Secretary, were present to answer questions and provide refreshments.

By suggestion of the Long-Range Planning Committee (LRPC) the Stewardship Committee is sharing the financial state of EPC in a more transparent way, by use of the church bulletin board, newsletter and bulletins. Several articles have been published in the newsletter in 2022. Financial details and recommendations made by the Presbyterian Foundation were shared with the entire congregation at the LRPC meeting held on September 25.

An exciting accomplishment for our committee and the church is the addition of Eastminster to the list of charities eligible to receive a portion of purchases made while shopping on SmileAmazon.com.
